

Minutes of 2nd Meeting of FEE Fixation Committee

16th April 2024, 11am

The meeting commenced with Prof. Sunil Bhirud, Hon. Vice Chancellor, COEP Technological University welcomed all the members of the Fee Fixation Committee present online and Offline. He briefed the members that the University had tried to regulate the fees by meticulously charting the exact fee heads with appropriate nomenclature, break-ups and upper limit as per the MahaDBT portal. The proposed fee's structure was discussed in the Heads/ Directors/ Deans meeting. Due deliberations and discussions were held to work out the proposed fee structure while incorporating their inputs. Dr. D. N. Sonawane, Registrar and Member Secretary of the FEE Fixation Committee requested Chairman to start the proceedings. The Chairman permitted to start the proceedings as per the agenda points.

Agenda 2.1: Confirmation of Minutes and ATR of 1st Fees Fixation Meeting July 04, 2023

Minutes of the 1st meeting of the Fee Fixation committee held on 3rd July 2023 and the Action Taken Report (ATR) was presented by Dr. Sonawane to the committee for its consideration and approval. Pertaining to the fees of self-financed programs, Prof. Dhokey made the following suggestions.

- The discussion and deliberation that establishes the foundation for setting a fee structure for a specific program(s) should be appended as an annexure to the Meeting Minutes for easy reference in the future.
- Explaining the allocation and usage of fees collected for self-financed undergraduate or postgraduate programs.

Resolution-2.1: The members RESOLVED to APPROVE the minutes and the Action Taken Report of the 1st meeting Fee Fixation Committee held on 3rd July 2023.

Agenda-2.2: Approval of the proposed fees structure of UG/PG/MBA programs for AY: 2024-25

Dr. Sonawane provided a breakdown of per-student expenditure for the academic years 2022-23 and 2023-24 (**details appended as Appendix- 1**). He noted that the per-student expenditure for the year 2022-23 was initially presented as Rs. 1,89,000/- but after undergoing an audit it was subsequently adjusted at actual to Rs. 1,54,457/-. Additionally, the per-student expenditure for the academic year 2023-24, totaling Rs. 1,50,163/-, was regarded as the baseline for establishing the proposed new fee structure for the forthcoming academic year 2024-25.



Proposed fees structure of UG programs

While presenting the proposed fee structure applicable for the First Year UG programs for the batch of students to be admitted in the Academic Year 2024-25 through the Common Entrance Test administered by the State CET Cell, JEE, Gulf Quota and NRI/OCI/FN quota, Dr. Sonawane emphasized that the University has proposed an overall 5.2% increase in the total fees (detailed fee structure appended as Appendix- 2). This increase involves adjustments in two key components:

- The tuition fees are set to rise from Rs. 15,000/- to Rs. 17,000/-.
- The proposed fee structure has shown the Examination fee component, which was missing in the previous year's fee structure. The applicable examination fee is proposed to be Rs. 2500/-.
- Maintaining the consistency in the different heads of Other Fees as per the fee's heads given in MahaDBT portal.

Dr. Sonawane also mentioned that the University Students Insurance fund, which is reimbursed by the Government, is now displayed in the other fee component. Previously, it was shown under miscellaneous fees component.

Dr. Karmalkar and Dr. Sayyad expressed concern that the suggested examination fees might not sufficient and may not cover all the expenses associated with the exam administration and suggested that the University should consider setting the examination fees at least at Rs. 2750/-, as it was in-line with examination fee of AY 2022-23.

They further suggested that the University should institute a Disaster fee and Ashvamedha fees in accordance with Government GR & guidelines. This fee can be utilized as per the Government guidelines.

Pertaining to the proposed fee structure applicable for the First Year UG programs for the batch of students to be admitted in the upcoming Academic Year 2024-25 admitted through NRI/OCI/FN Category, Dr. Sonawane highlighted that the University has reinstated the fees applicable to these students as approved in Academic Year 2022-23 (detailed fee structure appended as Appendix- 2). He appraised to the members that in the AY: 2023-24, the University has reduced the NRI/OCI/FN category fees to \$5000 from \$6250 in line with other Govt. Institutions and an attempt to boost their enrollment.



However, the University has reverted the tuition fees back to \$6250 reinstating it to the fees of AY 2022-23. Additionally, examination and other fees maintained consistent for all other students regardless of their admission category.

In nutshell, for FY UG students, it has been proposed that:

- The tuition fees are set to rise from Rs. 15,000/- to Rs. 17,000/-.
- The Examination fee is proposed to be Rs. 2750/-.
- Overall fees of Open category students are proposed to Rs. 1,42,240/- for the AY: 2024-25 from Rs. 1,35,200 charges for the previous academic year AY: 2023-24.
- The fees of NRI/OCI/FN Category students are reinstated to \$6250 for the AY: 2024-25 from \$5000 charges for the previous academic year AY: 2023-24.

Proposed fees structure of PG programs

(Detailed fee structure appended as Appendix-2)

PG Programs in Engineering (MTech) and Planning (M. Plan)

Dr. Sonawane notified the committee that there have been no alterations in the overall fees for postgraduate students to be admitted in regular PG programs in Engineering and Planning through GATE or under the Sponsored category in case of the MTech. Automotive Technology. Nonetheless, the examination fee, previously included under other fees, is now displayed as a distinct component starting this year. It is also proposed to uphold consistency in the other fee component by aligning the fees charged to postgraduate students with those charged to undergraduate students.

PG Programs in Management (MBA)

Dr. Meshram, Dean of School of Transdisciplinary Sciences and Management appraised the committee that the MBA department is currently offering two specializations namely MBA in General Administration and MBA in Business Analytics. The department has proposed increase in the intake of their MBA in General Administration programme from 30 to 60 from the upcoming Academic Year 2024-25. In order to strengthen the Department further, on-boarding good full-time faculty is imperative. The department has therefore proposed to increase the fees for AY 2024-25 to Rs. 3,00,000/- from Rs. 2,08,000/- resulting rise in the previous year's fees by 44%.



PG Programs Proposed Under University Ambit

Dr. Sonawane informed to all the members that the fee structure for M. Tech programs in Data Science and Cyber Security remains unchanged for the upcoming Ay 2024-25. Furthermore, the University has proposed M. Tech in Automotive Systems for working professionals from AY: 2024-25. An MOU with M/s. Hella Automobile has been signed in accordance with same. An intake of 30 students is proposed for the said programme. The courses will be conducted in hybrid mode by the industry experts. The fess for the said program is proposed as Rs. 3,00,000/-similar to other M Tech programs started under university ambit.

Upon reviewing the proposed fee structure for the PG programs for the upcoming year AY 2024-25, the committee members made the following suggestions.

- Mr. Bharat Gite suggested that the University must undertake measures to encourage its undergraduate students to pursue an MBA at COEP Tech.
- In light of the rising demand by the corporate sector, Dr. Karmalkar proposed the inclusion of credit courses in Financial Forensic Audit within the current MBA curriculum.
- Anticipating future learning trends, Dr. Karmalkar recommended that the University should allocate a limited number of seats for working professionals who are interested in taking selected credit courses. A distinct fee structure may apply to these candidates.

Resolution 2.2: The members RESOLVED to APPROVE the proposed fees structure of regular UG/PG/MBA programs for AY: 2024-25 with the following changes.

- For UG students, rise in Tuition fee from Rs. 15,000/- to Rs, 17,000/- effective from AY 2024-25
- Showing the examination fees of Rs. 2750/-explicitly in the proposed fee structure for AY 2024-25.
- Rise in the Overall fees by 5.2% (increase in fees from Rs. 1,35,000/- to 1,42,230/-) in case of students admitted through CET and 5.17% (increase in fees from Rs. 1,55,200/- to 1,63,230/-) for candidates admitted under JEE and Gulf Quota.
- Instituting Disaster Fees and Ashvamedha fees as per the Government GR & Guidelines.
- Fees for NRI/OCI/FN students reinstated to AY 2022-23 to \$6250. Exam fees and other fees are the same as applicable to regular students.
- No change in the fees of PG programs in Engineering and Planning.
- Rise in fees of MBA programs by 44% i.e. from Rs. 2,08,000/- to 3,00,000/-
- Approval of fees of Rs. 3,00,000/- for the M. Tech Automotive Systems proposed to start from AY: 2024-25 for the working professionals.



Agenda-2.3: Approval of the proposed fees structure of S.Y. B.Tech. Working Professional Category for AY: 2024-25.

Dr. Sonawane briefed the committee that commencing from the academic year 2024-25, the University will start a separate division in S Y B Tech Mechanical, Electrical and Manufacturing Engineering for working professionals as per the approval and guidelines of AICTE and further to State Government. Working professionals with a diploma will have the opportunity for direct lateral admission into the second year of B. Tech programs at the Departments of Mechanical Engineering, Electrical Engineering, and Manufacturing Engineering & Industrial Management. Admission procedures for these candidates will be centrally administered as per the policies of the State Government, with the applicable fee structure identical to that of candidates admitted under the JEE quota with overall fees of Rs. 1,63,230/-. (Detailed fee structure appended as Appendix-4)

Resolution 2.3: The members RESOLVED to APPROVE the proposed fees structure of S.Y. B.Tech. for Working Professional Category which will be same as applicable for candidates admitted under JEE Quota for AY: 2024-25 with overall fees of Rs. 1,63,230/-.

Agenda-2.4: Ratification and Approval of Proposed Fees Structure of PhD Program Effective From January 2024.

Dr. Sonawane presented the Proposed Fees applicable for the candidates admitted to Part-Time and Full-Time PhD Program, effective from January 2024 Batch. He added while working out the fee structure for Ph.D candidates, the University laid focus on attracting more working professionals on board. Fees applicable for the full-time candidates will be Rs. 48.750/- per year while Rs.96,700/- per year for part-time candidates. (Detailed fee structure appended as Appendix-5)

Resolution 2.4: The members RESOLVED to APPROVE the the fees for full-time PhD students as Rs. 48.750/- per year while Rs.96,700/- per year for part-time PhD students Effective From January 2024.



Agenda-2.5: Approval for the proposed fees structure of Post Graduate Diploma (PGD) programs for AY: 2024-25.

Dr. D. N. Sonawane presented the proposed fees structure of one-year full-time Post Graduate Diploma (PGD) programs. He emphasized that these programs are autonomously operated by the respective Departments. (Detailed fee structure appended as Appendix- 6)

Resolution 2.5: The members RESOLVED to APPROVE the proposed fees structure of Post Graduate Diploma (PGD) programs as well as members authorized the respective HOD to decide the fees structure of PGD program/s while discussing in Department faculty meetings and in Department Board of Study meetings subsequently members empowered Hon'ble VC to approve the fees of PGD programs.

Dr. D. N. Sonawane and Chairman thanked all the members for attending the Fee Fixation meeting and declared conclusion of the same.
