### **DOCUMENTS FOR STUDENTS (Applicant)**

- 1) Completely filled in Loan Application Form
- 2) Completely filled in Bio Data Form
- 3) **Pan card (mandatory)**
- 4) **Aadhaar card (mandatory)**
- 5) Two Recent passport size photographs
- 6) Bank account statement
- 7) Bonafide Certificate of the student
- 8) Receipt cum Acknowledgment of institute for admission
- 9) Mark sheets of the student from 10<sup>th</sup> onwards
- 10) Expenditure Certificate [mentioning Tuition fees, laptop(if required), lodging, boarding, books & stationery etc.]

### **DOCUMENTS FOR PARENT/GUARDIAN**

- 1) Two Recent Passport Size Photographs
- 2) **Pan Card (Mandatory)**
- 3) **Aadhaar card (mandatory)**

### **DOCUMENTS FOR SALARIED**

- 1) Latest 3 months salary slips
- 2) Latest Form 16 for two years
- 3) Salary account statement for last 6 months
- 4) All Loan A/C statements for atleast one year, if any
- 5) Income Certificate from Tahasildar (for non-salaried person)

### **DOCUMENTS FOR SELF EMPLOYED**

- 1) IT returns for the latest 3 years along with financial documents i.e. Computation of income, P & L and Balance Sheet
- 2) Bank account statement for one year
- 3) Shop Act Licence
- 4) Brief write up about the business venture

### **DOCUMENTS FOR AGRICULTURIST**

- 1) **Income Certificate from Tahasildar (for non-salaried person)**
- 2) **Copy of 7/12 extract**
