Admission Notice for M. Tech and M. Planning at COEP Technological University, Pune

Applications are invited from the candidates aspiring for admissions to First Year Full-time courses in **M. Tech** and **M.Planning** at COEP Technological University (COEP Tech), Pune for the Academic Year 2025-26.

Process of application: The Candidate shall register online on COEP Tech website (www.coeptech.ac.in), the candidate shall fill & submit online application form and upload the required documents from anywhere through the computer connected to internet and he/she need not have to visit personally for verification of the application form. His/her application & documents shall be verified and confirmed by the COEP Tech, E-Scrutiny Center through online mode only (refer activity schedule for details).

Eligibility criteria for candidates for admission in M. Tech (Various Specializations)

Maharashtra State, All India Candidature Candidates

- 1. The Candidate should be an Indian National;
- 2. Passed bachelor's degree in the relevant field of Engineering and Technology from All India Council for Technical Education or Central or State Government approved institutions or equivalent, with at least 50% marks (at least 45% marks in case of candidates of Backward Class categories, economically weaker section and Persons with Disability category belonging to Maharashtra State);
- 3. Passed bachelor's degree in the relevant course of Engineering and Technology as specified in the eligibility criteria for admission to a Post Graduate Degree course of COEP Technological University for which admission is being sought
- 4. Obtained Qualified score in Graduates Aptitude Test in Engineering (GATE)conducted by the Indian Institute of Technology and valid for the current academic year;

OR

Obtained non-Qualified marks in Graduates Aptitude Test in Engineering(GATE) conducted by the Indian Institute of Technology for the current academic year;

OR

For sponsored candidates, minimum of two years (730

- 5. GATE Qualified Candidates shall have preference over the not qualified Candidates.
- 6. "Non-GATE_Non-Sponsored" means candidates neither appeared for GATE examination, nor have any work experience and sponsorship letter.
- 7. The candidates applied in "Non-GATE_Non-Sponsored" category shall be eligible only in CAP Round IV. These candidates must appear for "University Common Entrance Test" conducted by the university as per the scheduled declared. The details of the Entrance Test will be published on the university website.

Eligibility criteria for candidates for admission in M. Planning (Town and Country Planning)

Maharashtra State, All India Candidature Candidates

1. The candidate should be an IndianNational;

- 2. Passed bachelor's degree in planning/ architecture/ civil engineering OR Passed master's degree of Geography/ Economics/Social Sciences or equivalent Degree with at least 50% marks (at least 45% marks in case of candidates of Backward Class categories, Economically Weaker Section (EWS)and persons with disability category belonging to Maharashtra State only)
- 3. Obtained nonzero positive score in common Entrance Exam for Design (CEED) conducted by Indian Institute of Technology.

OR

4. Obtained qualified score in Graduate Aptitude Test in Engineering (GATE) in Civil Engineering/Architecture and Planning conducted Indian Institute of Technology and valid for the

Children of NRI/OCI/PIO, Children of Indian workers in Gulf Countries (CIWGC), Foreign National (FN) Candidates

- (iv) Passed bachelor's degree in planning/ architecture/ civil engineering OR Passed master's degree of Geography/ Economics/ Social Sciences or equivalent Degree with at least 50% marks.
- (v) Any other criterion declared from time to time by the appropriate authority as defined under the Act.

However, preference shall be given to CEED appeared candidate over the GATE appeared candidate. GATE or CEED qualified candidates shall have preference over the non-qualified candidates.

- 5. For sponsored candidate's minimum of two years full-time work experience in registered firm or company or industry or educational or research institute of any government department/government autonomous organization in the relevant field in with admission is being sought.
- 6. "Non-GATE_Non-Sponsored" means candidates neither appeared for GATE examination, nor have any work experience and sponsorship letter.
- 7. The candidates applied in "Non-GATE_Non-Sponsored" category shall be eligible only in CAP Round IV. These candidates must appear for "University Common Entrance Test" conducted by the university as per the scheduled declared. The details of the Entrance Test will be published on the university website.

Important Instructions for candidates

- 1. All the rules and regulations of admission for the academic year 2025-26 will be in accordance and governed by information brochure published on university website https://www.coeptech.ac.in/admission/post-graduate/
- 2. If candidate fails to submit online application (completed with uploading required documents) through the link provided on the university then such incomplete applications will be rejected, and name of such candidates will not appear in the merit list(s) prepared during the process of Admission.
- **3.** *EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section (Proforma-V).
- **4.** *ECBC candidates shall produce the Eligibility Certificate for Economically Weaker Section (Proforma-V).
- **5.** Sponsored candidates should produce certificate of Employer (Profroma-P)as given in information brochure available on https://www.coeptech.ac.in/admission/post-graduate/ for the academic year 2025-26.
- **6.** For Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant and /NRI/PIO/OCI/CIWGC/FN Candidates:- Such Candidates will get the Receipt-cum-Acknowledgement through their login after confirmation of application by E-Scrutiny center of COEP Tech. Applications received after the last date from candidates will be summarily rejected and no correspondence will be entertained in this regard.
- 7. Candidates who have registered as a reserved category candidate but unable to produce

- required certificate for reservation claim during E-documents verification stage shall have to pay difference of fee of Rs. 300/- through online mode only and such candidates will be considered as OPEN category candidates.
- **8.** A Candidate who has been allotted a seat shall confirm the seat by reporting at College of Engineering Pune. Non-Confirmation/ Non-reporting by candidates for the provisional allotment will be treated as cancellation of allotment to the particular seat and will be shown as vacant in subsequent allotment round.
- **9.** The Seat Acceptance Fee shall be Rs.1000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first reporting only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fee is to be paid through His/ Her Own login by ONLINE MODE only.
- 10. As per the allotment, seat will be confirmed by COEP Tech after verification of the original documents and ensuring that the Candidate meets all the eligibility norms and the requisite fee by the COEP Tech. The admission in-charge of COEP Tech shall issue the Online Receipt of admission confirmation to the candidate.
- 11. The SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC and EWS Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non-Creamy Layer Certificate, EWS Certificate during registration, e-verification or physical document verification and confirmation period should upload and verify original Caste/ Tribe Validity Certificate, Non-Creamy Layer Certificate, EWS Certificate at Physical Scrutiny Center or E-Scrutiny Center and submit original certificate to the admitted institute on or before third round last date of reporting otherwise these candidates' admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate full fill eligibility criteria for open category.
- 12. For detailed instructions please refer to the information brochure for postgraduation published on the university website.
- 13. The candidates applied in "Non-GATE_Non-Sponsored" category shall be eligible only in CAP Round IV. These candidates must appear for "University Common Entrance Test (UCET)" conducted by the university as per the scheduled declared. The details of the Entrance Test will be published on the university website. Such candidates shall regularly visit the university website for updates regarding UCET examination.
- **14.** Allotment of the seats in this round will be carried out based on eligibility and availability of the seat in the respective category by inter-se-merit of the marks secured by the candidates in "University Common Entrance Test".
- 15. If total number of admitted candidates in a particular programme are less than 10 (TEN), then that programme will not be offered in academic year 2025-26. The complete fee will be refunded to the candidate admitted to such programme.
