The candidate who wishes to apply / participate in this University Level ACAP / spot round needs to **MANDATORILY** register for a SPOT (ACAP) round on or before 3.00 PM, 2nd September 2025. Follow the instructions as per the link given below and pay the required processing fees.

- Please note Fees Payment through SBI Collect is ONLY Permissible for payment of SPOT Round Application Fees. However, for Payment of Admission Fees "Demand Draft" is the only Mode of payment permissible.

Stages of Admission round will be as per the information brochure of GOVERNMENT OF MAHARASHTRA State Common Entrance Test Cell for the Academic Year 2025-26, for admissions to full time Professional Undergraduate

NOTE for ACAP (Non-CAP seats) Registered Candidate:

1. **NON-CAP Registered candidates should register on NON-CAP Google Form Link only.**
NON-CAP means Candidates whose name did NOT appear in Final Merit List for Published by CET-CELL Mumbai.

For Working Professional - Direct Second Year B.Tech. admission activity during ACAP/Spot Round 2025

Sr. No.	Activity
1	Reporting of candidates to Main Auditorium, COEP Technological University, Pune strictly as per the schedule mentioned in Table No-1. The candidate(s) are required to bring requisite University fee (of Rs. 1,63,240/-) in the form of Demand Draft ONLY.
2	Payment of Nonrefundable Admission SPOT Round Processing fee of Rs.1500/- (One thousand five hundred only) for OPEN category candidates and Rs.1200/- (One thousand two hundred only) for reserved category candidates should be made on or before 2 nd September 2025 till 3.00 PM (IST). Mode of payment is online through SBI collect and bring the hard copy of transaction receipt at the time of reporting. 3	Verification of applicable original documents as notified by CET Cell and submission of TWO sets of photocopies of these documents.
4	Call for seat allotment by counseling as per inter-se merit.
5	Submission of requisition form for seat allotment. Form will be issued at the venue, at the time of spot round.
6	Payment of University / Institute Admission Fee in the form of ONLY Demand Draft issued in favor of "COEP Technological University" Payable at Pune.
7	Seat allotment based on available vacancy at that moment.
8	Submission of required original documents along with one set of photocopies of these documents.
9	Confirmation of the allotted seat to the candidate.
10	Issue of admission confirmation receipt to the candidate.

Instructions:

1. The admissions to the Working Professional - Direct Second Year of undergraduate programs at COEP Technological University, Pune for the Academic Year 2025-26 will be conducted by Direct Counseling (Spot) Round against vacant seats available after CAP Round II of CET CELL for the admission for the Academic Year 2025-26.

2. These admissions will be made strictly in the order of inter-se merit amongst the candidates who report in person for admission to COEP Technological University, Pune against the seats available in various courses / programs at that moment.
3. The candidate will lose the claim to participate in the admission counseling process if he/she fails to produce all the applicable original documents at the time of document verification during the counseling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the original admission letter and fee receipt. The candidate should submit an undertaking stating that he/she will submit original documents within four working days from the date of reporting.
4. At the time of seat allotment by counseling, the candidate is required to submit “**Requisition for Seat Allotment.**” (Form will be issued at the venue, at the time of spot round)
5. The seat allotment will be carried out based on the vacancy status at that point. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the Counseling Hall (main auditorium) and wait for their turn as per inter-se merit. If a candidate is found unavailable when called, the next candidate on the merit rank would be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.
6. If a candidate of higher merit reports late during the process of counseling; in that case, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that moment. The decision of the admission center in-charge shall be final and binding.
7. Confirmation of the allotted seat to the candidate is subject to the payment of the requisite University admission fees in **Demand Draft** issued in favor of “**COEP Technological University**” payable at Pune, applicable original documents, anti-ragging form and academic bank of credits (ABC) immediately in online mode, such candidate confirms admission through the acceptance of the allotted seat at COEP Technological University, Pune.
