- 1. Sealed quotation to be addressed to "The Vice-Chancellor, COEP Technological University" and to be submitted at MindSpark Office, Manufacturing Department, Hall above the Fab Lab, COEP Technological University, Shivajinagar, Pune-411005 on or before the specified deadline during office hours (9 am to 5 pm).
- 2. All submitted quotations must strictly adhere to the particulars and quantities specified in the Call for Quotation.
- 3. Quotations received after last date of submission will be rejected.
- 4. Quotations should be signed by the authorized signatory.
- 5. The rates mentioned in the quotation must remain valid for a period of **six (6) months** from the date of submission.
- 6. Quotations sent via email will not be accepted and will be disqualified.
- 7. The University reserves the right to reject any or all quotations in case of incomplete, incorrect, or non-compliant submissions.
- 8. The University reserves the right to procure any item in any quantity, irrespective of the initial requirement, without providing any justification.
- 9. Quotations must be submitted in a properly sealed envelope clearly mentioning the name and stamp of the firm. Unsealed or improperly sealed envelopes are liable to be rejected by the MindSpark'25 team.
- 10. All relevant supporting documents must be enclosed with the quotation.
- 11. All interested vendors must possess a valid pan card number and a GST number.
- 12. The Vendor shall acknowledge and accept the Purchase Order within 2 days from the date of issuance of Purchase Order.
- 13. Taxes, transportation, and any additional charges must be **mentioned separately** in the quotation.



- 14. GST will be paid only for those deliverables that fall under GST regulations. Vendors must provide a valid **GST number and GST certificate**. Failure to do so will result in non-payment of the GST component.
- 15. 100% payment will be made **only after completion of MindSpark'25**, and for goods received in good condition.
- 16. Quantity may vary as per event requirements.
- 17. Quotation opening date, time and venue will be notified.
- 18. No advance payment will be made under any circumstances.
- 19. In case of late delivery of the materials, a penalty amount will be deducted from the total payable.
 - a) For Purchase Orders valued below ₹2,00,000: Penalty at the rate of **0.5% per week** of delay, subject to a maximum of **10% of the Purchase Order value**.

- b) For Purchase Orders valued at ₹2,00,000 and above: Penalty at the rate of **0.5% per week of delay**, subject to a maximum of **5% of the Purchase Order value**.
