Announcement of Institute Level (Spot) Round on 12th September 2025 for M. Tech and M. Planning programs at COEP Technological University for the Academic Year 2025-26

Candidates Eligible to participate in Institute Level Round:

1. All candidates who have already taken admissions in CAP Round-I, II, III and IV (UCET) are eligible to participate in Institute Level Round, they need to bring their original admission receipts.
2. Non-GATE_Non-Sponsored candidates who have appeared and scored in the **UCET exam** will be considered for admission once the merit list of Non-sponsored GATE candidates gets exhausted. No new registrations are allowed in this category, also there will not be any additional UCET Exam to be conducted for this category.
3. All the candidates who have not yet registered and who have Non-zero Positive GATE score of 2025 and Valid (Qualified) GATE Score of 2022, 2023 or 2024 till the academic year 2025-26. These candidates must register to the link provided on the COEP Tech website.
4. Candidates belonging to **NRI/ OCI/ PIO/ CIWGC/ FN** and **Working Professional (for Automotive Systems/ Data Sciences)** category are also eligible in Institute Level (Spot) Round.
5. Institute Level (Spot) Round will be conducted through counseling (in-person) at Mini Auditorium, COEP Technological University campus.
6. Candidates must take immediate decisions based on the availability of vacant seats and confirm their admissions by submitting the demand draft of requisite fees.

| 4 | Submission of Institute Admission Fee in the form of Demand Draft in favor of “COEP Technological University” Payable at Pune. |
| 5 | Seat allotment based on available vacancy at that point of time |

| 7 | Confirmation of the allotted seat to the candidate |
| 8 | Issue of admission confirmation receipt to the candidate |

Application processing fee (mandatory for all participating candidates):

- Rs. 1500/- for OPEN category candidates
- Rs. 1200/- for reserved category candidates

Admission fees:

- All candidates must carry Demand Draft of admission fees in the name of “**COEP Technological University**”, payable at Pune as applicable to their category:
 - a) Candidates belong to OPEN, SEBC, EWS Category must pay admission fees Open Category as per fee structure
 - b) Candidates belong to OBC, SBC, VJDT, NT category (valid NCL, CV) and having annual income below 1.5 Lakhs will be eligible to pay fees as per their category as mentioned in the fee structure.

- c) The candidates belong to SC and ST Category are eligible to pay SC/ST category fees as mentioned in the fee structure.
- d) Candidates who have already admitted to COEP Technological University and appearing for Betterment they should carry their original admission letter to appear for institute level (Spot) round**

Important Instructions:

1. The admissions to the first year of postgraduate courses at COEP Technological University Pune in Institute Level (Spot) Round for the academic Year 2025-26 will be conducted by Counseling against vacant seats displayed on COEP Tech Website.
2. These admissions will be made **strictly** in the order of inter-se-merit amongst the candidates who report in person for admission to COEP Tech against the seats available in various branches at that point of time.
3. The candidate will lose the claim to participate in the admission counseling process if he/she fails to produce all the required original documents at the time of document verification during the counseling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the original receipt of his/her admission. The candidate should submit an undertaking stating that he/she will submit original documents within next four working days from the date of reporting.
4. After successful verification of the relevant original documents, the eligible candidates will be called for seat allotment by counseling as per inter-se merit.
5. The seat allotment will be carried out based on the vacancy status at that point of time. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats. Candidates are advised to be present in the Counseling Hall (Mini Auditorium) and wait for their turn as per inter-se merit. If a candidate is found unavailable when called, the next candidate in the merit list will be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.
6. Suppose a candidate of higher merit reports late during the process of counseling. In that case, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time. The decision of the admission center in-charge shall be final and binding.
7. Confirmation of the allotted seat to the candidate is subject to the submission of the requisite Institute admission fees through **Demand Draft in favor of “COEP Technological University” payable at Pune.**
8. If a candidate fails to pay the requisite admission fee at the time of seat allotment, such candidature will be withdrawn, and the seat will be allotted to the next candidate in the merit list. Payment through cash / cheque / online transfer will not be accepted under any circumstances.
