If Seats remain vacant after CAP Round – IV, ACAP (SPOT) Rounds will be conducted.

 - Candidate shall attach the requisite documents to substantiate the claim for any correction in the provisional merit list.

2	<p>Payment of Nonrefundable Admission ACAP (SPOT) Round Processing fee is Rs.1500/- (One thousand five hundred only) for OPEN category as well as AI candidates and is Rs.1200/- (One thousand two hundred only) for RESERVED category candidates. 3	Verification of applicable original documents as notified by CET Cell and submission of one set of photocopies of these documents.
4	Call for seat allotment shall be by counseling as per Inter-Se-Merit for candidates appearing in the Merit List Published by the COEP Technological University Pune.
5	Submission of requisition form for seat allotment. Form will be issued at the venue, at the time of spot round.
6	Payment of University Admission Fee in the form of Demand Draft issued in favor of "COEP Technological University" Payable at Pune.
7	All candidates must refer to the fee structure attached on the last page of this notification for fees applicable for admission to F.Y. B.Planning Programme through University Level ACAP (SPOT) round. The fee structure is also available on COEP Tech. website. The candidate(s) are advised to bring the DD(s) of appropriate amount of COEP Tech. University fees as applicable.
8	Seat allotment shall be based on available vacancy at that moment.
9	Submission of required original documents along with one set of photocopies of these documents.
10	Confirmation of the allotted seat to the candidate.
11	Issue of admission confirmation cum fee receipt to the candidate.

Instructions:

1. The admissions to the first year of undergraduate courses / programs at COEP Technological University, Pune for the Academic Year 2025-26 will be conducted by Direct Counseling (SPOT) Round against vacant seats available after CAP-IV round for the admission to B.Planning Programme for the Year 2025-26.
2. These admissions will be done strictly in the order of Inter-Se-Merit of the Merit List Published by COEP Technological University Pune and amongst the candidates who report in person for admission to COEP Technological University, Pune against the seats available at that moment.
3. The candidate will lose his / her claim to participate in the admission counseling process if he/she fails to produce all the applicable original documents at the time of document verification during the counseling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the original admission Letter (Receipt cum Acknowledgement letter) and fee receipt. The candidate should submit an undertaking stating that he/she will submit original documents **within four working days** from the date of reporting.
4. At the time of seat allotment by counseling, the candidate is required to submit "**Requisition for Seat Allotment**". Form will be issued at the venue, at the time of spot round.
5. The seat allotment will be carried out based on the vacancy status at that point or time / moment. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats. Candidates are advised to be present in the Counseling Hall (venue) and wait for their turn as per inter-se merit. If a candidate is found unavailable when called, immediately the next candidate as per Inter-Se-Merit would be called for seat allotment and the absent candidate may miss his/her chance of merit-based seat allotment.
6. If a candidate of higher merit reports late during the process of counseling; in that case, the candidate may be considered for allotment of a seat available at that point of time /moment for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that moment. The decision of the

admission center in-charge shall be final and binding.

7. Confirmation of the allotted seat to the candidate is subject to the payment of the requisite University admission fees in **Demand Draft** issued in favor of “**COEP Technological University**” Payable at Pune, applicable original documents, anti-ragging form and academic bank of credits (ABC) immediately in online mode, such candidate confirms admission through the acceptance of the allotted seat at COEP Technological University, Pune.
8. ***All dates and time notified here are in accordance with the schedule declared by the CET CELL Mumbai, and it may change as per the notification issued by CET Cell Mumbai time to time and will be notified on COEP Tech. website.***
9. Those who have registered for ACAP (SPOT) Rounds of COEP Technological University, Pune, need to keep watch for any updates regarding ACAP (SPOT) Rounds on COEP Tech. website. It's candidates' responsibility to keep watch on COEP Technological University Pune website for frequent updates.

- This fees structure is applicable to students newly admitted for AY: 2025-26 and may change from time to time as per the guidelines from the State Government and COEP Tech University.
- Studnets belonging to SC/ST/PWD/VJNT/OBC/SBC/EWS/SEBC/PMSSS [*] means their fees to be reimbursed from State/Central Government as freesheeps/scholarship for which student has to apply to Government in stipulated time period on MAHADBT portal.
- It is the sole responsibility of the student to apply (Online/Offline) to get benefit of freeship/scholarship to the State/Central Government. If the student does not apply for the reimbursement of the fees, then he/she will have to pay full fees as applicable to OPEN category studnets.
- In case, if the Government for any reason does not reimbursed the fees to the reserved category student, then he/she will have to pay the difference in fees as mentioned in table within three weeks of receipt of such information from MAHADBT portal to the studnet.
- Students are advised to visit COEP Tech website and aslo contact to scholarship section of the University (020-25507056) for information related to the various scholarships/freeships and the deadlines to apply for the same, failing which the student will not be eligible to avail any benefit.
- PWD srudents shall pay the full fees, after the admission PWD candidates need to apply on MAHADBT portal for fee reimburement.
