Sir,

With reference to your letter No. COEPTech/New VC/5217 dated 22.11.2022 received through e-mail, I am directed to say that **COEP Technological University, Wellesley Road, Shivajinagar, Pune- 411005 Maharashtra** bestowing the College of Engineering Pune (Autonomous College) with the status of non affiliating Unitary Technological Public University has been notified on **21.06.2022 (Notification No. Sankirn-1111/(36/20)/TE-2 dated 21.06.2022)** by the **Maharashtra COEP Technological University Act, 2022 (Maharashtra Act No. XXXV of 2022)** as a State University. The University is empowered to award degrees as specified by UGC Notification on "Specification of Degrees 2014" and its amendments issued from time to time under section 22 of the UGC Act 1956 by conducting courses through its own departments. The name of the University has been included in the list of universities established as per Section 2(f) of UGC Act. 1956, as maintained by the UGC on its website www.ugc.ac.in.

The University shall operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location, as per the Hon'ble Supreme Court Judgment in Prof. Yash Pal vs. State of Chhattisgarh case.

The University may note and adhere to the following: -

- i. To ensure that no off campus center(s)/study center(s) is opened beyond the territorial jurisdiction of the University as stipulated in the Act and in no case beyond the territory of the State.
- ii. To ensure that no programmes should be offered through franchising arrangement with private institutions.
- iii. To ensure that no study center(s) are opened through franchises by the University.



- iv. In case the university has already started any off-campus/study center and the center operating through franchises outside the State, it must be closed immediately.
- v. No Open and Distance Learning Programme and on-line programmes shall be started without the prior recognition of UGC. Relevant UGC Regulations are available on the UGC website www.ugc.ac.in.
- vi. Ph.D programmes can be conducted as per the provisions of University Grants Commission (Minimum Standards and Procedures for Award of Ph.D.Degree) Regulations, 2022.
- vii. The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.

Kindly find enclosed a copy of UGC (Fitness of Technological Universities for Grants) Rules, 1978. The detailed information in the prescribed format (attached) may be sent to this office for considering the proposal to declare University fit to receive Central assistance under Section 12(B) of UGC Act, 1956.


