4. The candidates who have submitted a Ph. D. thesis are also eligible to apply.

The candidate should submit the online application form, upload the single PDF file including all necessary scanned copies of documents/certificates with name of file as “*Department initials*” and pay online application fees. The application fee for **Open Category candidates is Rs. 1000/-** (Rs. One Thousand Only) and for **Reserved Category / physically handicapped candidates is Rs. 500/-** (Rs. Five Hundred Only) **The application fee paid is non-refundable**. Please attach the fees paid as receipt with the application form.

The hard copies of duly filled-in application with signature, self-attested photograph with all required self-attested copies of the certificates/documents will have to be submitted at the time of personal interview.
11. Shortlisted candidates called for interview will have to present themselves at their own cost.
