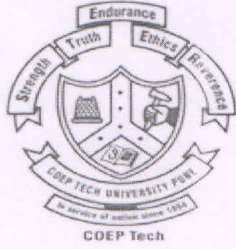



Terms and Conditions of the bidder:

1. The quotations are invited for the pest control of hostel premises for the bed bugs (Hostel blocks rooms, Guest House, V.C. Bungalows, Chief Rector, Rectors and Staff quarters and Messes etc).
 - A) The contract will be for One year; if service not satisfied the contract will be terminate without any intimation at any time.
 - B) Poor performances of services will be liable to appropriate reduction in payment/ termination of contract without notice.
 - C) No advanced payment will be done.
 - D) Our institution is not responsible for staff employed by the bidder. The Bidder will be responsible for the staff working on our campus; they are responsible for all the legal and government rules (Labour Law) and regulations regarding wages workman's compensation. EPF. ESI. etc.
 - E) Agency will be solely responsible for health and safety of the manpower deployed on the campus to carry out the required work.
 - F) The bidders are advised to visit the campus and study the exact nature of work expected before submitting the bid.
 - G) The university reserves rights to reject one or all quotations at any stage without assigning any reasons there for.
 - H) COEP Tech. Hostel has 611 rooms, 3 Guest House; 5 Messes, 01 V.C. Bungalows, 08 Rectors Qtrs. and 11 Staff quarter's etc. bed bugs problem is common in hostel student rooms. Agency will be responsible for total elimination of bed bugs, Cockroaches, Rat, Lizard, Spider and Ants etc. for the period of 1 year and will carry out necessary pest control.
 - I) Agency will maintain systematic record of the pest control carried out during the period of the contract. and reports to the hostel office.
 - J) Employee of the agency working in hostel campus must be in uniforms of the company and Identity Card.
 - K) Regular supervision of the work and reporting to the hostel authorities is required. Agency supervisor must present during the pest control work.
 - L) If a complaint is received or changes will be from students or from the hostel staff/authorities the same should be complied within 24 hours. For this, No extra claim is admissible.
 - M) During the pest control operation, theft/ loss of item from the student's rooms should not happen; the care will be taken by the supervisor during the working timing.
 - N) The agency will carry out necessary pest control as many times as required during this period. However minimum frequency will be once in 3 months or total five iterations in one year. The offer should be for entire job and payment will be done as follows.
 - O) Minimum Four (4) iterations of pest control are required for one year.
 - P) Substantially low offers will be analyzed critically in view of effective application, if found unsound, will likely to be rejected.
 - Q) Unsatisfactory services by any agency, if proved the offer will be rejected.

(A) Pest Control Iteration and Payment Schedule

2. Bid Price:

- A) The contract shall be for the full quantity as described above.
- B) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- C) The rates quoted by the bidder shall be fixed for the duration of the contract shall not be subject to adjustment on any account/reason.
- D) The prices should be quoted in Indian Rupees only.

3. Each bidder shall submit only one quotation.

4. Validity of Quotation:

- A) Quotation shall remain valid for the period not less than 180 days after the deadline date specified for submission.

5. Eligibility:

- A) Agency should have annual turnover for last three years Rs. 20 Lakhs. (Income Tax returns to be submitted).
- B) Similar job done minimum 2 Times. in a single year.
- C) List of earlier services provided to various agencies and their valid satisfactory completion certificate (minimum three).
- D) Appropriate registration with Govt. /Semi Govt. /Corporation.

6. Evaluation of Quotation:

Hostel committee will evaluate and compare the quotations determined to be substantially responsive, complying eligibility criteria and competent to deliver the satisfactory service.

7. Award of Contract

- A) Institute will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- B) Notwithstanding the above, the Institute reserves the rights to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

C) (Institute) prior to expiration of the quotation validity period, Institute will notify the bidder whose bid is accepted of the award of contract. The terms of the accepted offer shall be incorporated in the purchase order.
