Important Instructions for candidates

- 1 A Candidate who has been allotted a seat shall confirm the seat by reporting at COEP Technological University Pune. Non-Confirmation/ Non-reporting by candidates for the provisional allotment will be treated as cancellation of allotment to the particular seat and will be shown as vacant in subsequent allotment round.
- 2 As per the allotment, seat will be confirmed by COEP Tech after verification of the original documents and ensuring that the Candidate meets all the eligibility norms and the requisite fee by the COEP Tech. The admission in-charge of COEP Tech shall issue the Online Receipt of admission confirmation to the candidate.
- 3 **The SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC and EWS Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non-Creamy Layer Certificate, EWS Certificate during registration, e-verification or physical document verification and confirmation period should upload and verify original Caste/ Tribe Validity Certificate, Non-Creamy Layer Certificate, EWS Certificate at Physical Scrutiny Center or E-Scrutiny Center and submit original certificate to the admitted institute on or before second round last date of reporting otherwise these candidates’ admission will get**

automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate full fill eligibility criteria for open category.

- 4 For detailed instructions please refer to the information brochure for post-graduation published on the university website.**
- 5 The candidates applied in “Non-GATE_Non-Sponsored” category shall be eligible only in CAP Round IV. These candidates must appear for “University Common Entrance Test (UCET)” conducted by the university as per the scheduled declared. The details of the Entrance Test will be published on the university website. Such candidates shall regularly visit the university website for updates regarding UCET examination. Allotment of the seats in this round will be carried out based on eligibility and availability of the seat in the respective category by inter-merit of the marks secured by the candidates in “University Common Entrance Test”.
- 6 If total number of admitted candidates in a particular programme are less than 10 (TEN), then that programme will not be offered in academic year 2026-27. The complete paid fees will be refunded to the candidate admitted to such programme.**
